



Submissions

The CILT Award is to honour outstanding achievements in the logistics
The four assessment criteria are and transport industry in Hong Kong. It is open to local companies and organisations of all sizes in supply chain, logistics and transport sectors.

The theme for this year is 'Service Excellence through Digitalisation'. Digitalisation has becoming a more important part of businesses, the use of digital technologies and internet-based platforms has changed the landscape of business model, streamlining processes, improving productivity, developing new revenue streams and creating value-producing opportunities. With this Award, CILTHK wishes to raise the awareness of digitalisation in transforming supply chain, logistics and transport industries, and encourage the industry to share their successful stories. Two awards categorised into the 'Enterprise Award*' and 'SME Award**' will be selected.

Interested parties are required to submit a completed entry form as described on page 4 of this flyer together with a one-page executive summary and a submission paper in English with no more than 4,000 words to critically discuss the four areas listed in the assessment criteria.

The submission paper should be in pdf format and typewritten in English (Enterprise and SME) will be with no more than 4,000 words (font size at least 12 points Times New Roman or equivalent), including charts, tables, diagrams, photos and other illustrations (approximately not more than 30 pages). Each company/organisation is allowed to submit one entry only

Remarks:

- *An Enterprise is defined as -
- 1) a manufacturing company which employs 100 or more persons in Hong Kong;
- 2) a non-manufacturing company which employs 50 or more persons in Hong Kong

**An SME is defined as -

- 1) a manufacturing company which employs fewer than 100 persons in Hong Kong;
- 2) a non-manufacturing company which employs fewer than 50 persons in Hong Kong. transport or related fields.

as follows:

- Customer satisfaction (Internal User Buy in or Public Acceptance)
- Significance in business operations, benefits and impact
- Innovation, creativity and uniqueness in applications
- System continuity and upgradability (scalable and sustainable), functionality and integrability



A shortlist of entries will be drawn up and the finalists will be invited to a presentation in late August 2022. The Award winners announced in September 2022.



Two rounds of assessments will be conducted. The panel of the final assessment shall consist of 5 judges, including 2 representatives from the Council of CILTHK and 3 professionals from the logistics.

Award Presentation and Use of CILT Award Logo

Presentation of the Awards will be at the Institute's Annual General Meeting in September 2022. In addition, the winners will be granted the right to use the CILT Award Logo of the year to strengthen their reputation as well as corporate image for their quality service provided to the community.
