








































# 背景 Background

《香港物流新銳大獎》是由香港特區 政府在《現代物流發展行動綱領》倡 議,並在香港物流發展局支持年 港物流業界合作舉辦的物流業界合作舉辦的創 員在表揚和鼓勵在創新、高貢獻 對為人人。 是現卓越潛力的年青物流大眾引 過得獎者的成功故事,讓大眾引 過得獎者的成功故事,如 與者的發展新方向,如 知 知 知 知 一 步 發展。

The Hong Kong's NextGen Logistician Awards is an annual award for the logistics industry advocated by the HKSAR Government in the Action Plan on Modern Logistics Development and organised through collaboration of various sectors of Hong Kong's logistics trade with the support of the Hong Kong Logistics Development Council. It aims to recognise and encourage young talents in the logistics industry who have made significant achievements and shown remarkable potential in innovative, high-end, smart and green logistics, and through the success stories of the award winners, to introduce the new development directions of modern logistics to the public, with a view to attracting more young people to join the industry to propel its continual growth.

# 獎項類別及參選資格

# **Award Categories and Eligibility Requirements**

《香港物流新銳大獎2025》共設以下兩個獎項:

The Hong Kong's NextGen Logistician Awards 2025 has the following two award categories:

# 1. 傑出專業獎 Young Professional Award

此獎項旨在表揚在物流業表現出卓越才能和潛力,並致力於進一步發展的年輕從業員。獲提名者須在其參與的重要物流項目中有出色表現,尤其在創新、高端物流發展、智慧物流和綠色物流等領域。

在遞交提名時,獲提名者須擔任中層 或以下的職位,其年齡亦須為35歲或 以下。 The award aims to recognise young practitioners who have demonstrated remarkable talent and potential for further advancement in the logistics industry, as evidenced by exemplary performance in implementing major logistics-related projects they participated in, especially in the areas of innovation, high-end logistics development, smart logistics and green logistics.

Nominees must be at middle management level or below and under the age of 35 on the date of submission of application.

# 2. 創新領導獎 Young Executive Award

此獎項旨在表揚具有卓越領導才能的 年輕高級管理人員。除了在專業領域 有的成就外,獲提名者須對香港物流 業發展作出重大貢獻,尤其在創新、 可持續發展、促進區域和國際合作及 推廣等領域。

在遞交提名時,獲提名者須於物流業工作至少五年,並正擔任高級管理層職位,其年齡須為45歲或以下。

The award aims to recognise young executives at senior management level who have demonstrated leadership from strong and, apart accomplished in their professional capacities, have made substantial contributions to the development of Hong Kong's logistics industry, especially in the areas of innovation, sustainability, fostering of and international collaboration and regional promotion.

Nominees must have joined the industry for at least 5 years and are working at senior management level, with their age being 45 or below at the time of submission of nominations.

◆ 所有獲提名者必須持有有效香港居民身份證,並全職從事與物流相關的工作。提名必須由相關公司、 專業團體或行業協會提出。評審委員會只會就獲提名者在物流相關範疇的貢獻進行評審。

All nominees must possess a valid Hong Kong Identity Card and be engaged in full-time logistics-related duties in their current roles. They must be nominated by companies, professional bodies or trade associations relevant to the logistics industry. The Judging Panel will assess nominees based solely on their logistics-related contributions.

◆ 每位獲提名者只可被提名參加一個獎項類別。倘秘書處就某獲提名者收到多於一份提名表格,首份呈 交至秘書處的完整提名表格將被認定爲該候選人的有效提名者。涉及該獲提名者的其他提名將不予考 慮。

Any individual may be nominated for one award category only. If the Secretariat receives more than one nomination in respect of a given nominee, the first complete nomination form submitted to the Secretariat will be deemed the individual's valid nominator. Other nominations involving that nominee will not be considered.

◆ 每個獎項類別的得獎者數目不設上限或級別。獲提名者只要達到評審委員會設定的基準分數便可獲 獎。

There will be no limit on the number of winners for or assignment of different award levels in each category. Nominees who meet the benchmark scores set by the Judging Panel will receive an award.

# 提名資格 Nomination Requirement

- ◆ 所有在香港註冊、並涉及物流相關業務(例如設有物流部門)的公司、專業團體或行業協會均具 提名資格。獲認可的物流服務包括但不限於以下例子。評審委員會保留提名資格的最後決定 權:
  - 貨運服務 (空運、海運、鐵路運輸、公路運輸及多式聯運的最後一公里配送)
  - 倉儲與存儲服務 (倉儲、冷鏈存儲、配送、訂單履行及庫存管理)
  - 特定物流服務 (處理食品及醫藥品、危險品、重型及大型設備以及高價值貨品的物流服務)
  - 第三方、第四方及第五方物流服務(增值物流服務、物流顧問與管理服務以及端到端供應鏈優化)
  - 智慧與可持續物流 (綠色物流、智慧物流以及相關科技供應商)
- All companies, professional bodies, or trade associations registered in Hong Kong that are involved in the logistics-related business, for example, those with an in-house logistics department, are eligible to submit nominations. Examples of qualifying logistics services are provided below. The Judging Panel reserves the final authority to determine the eligibility for nominations.
  - Freight transportation services (air freight, sea freight, rail freight, road freight and any last-mile delivery via multimodal transport)
  - Warehousing and storage services (warehousing, cold chain storage, distribution, fulfillment and inventory management)
  - Specialised logistics services (logistics services for handling food, pharmaceuticals, dangerous goods, heavy equipment, oversized cargo, and high-value goods)
  - Third-party logistics (3PL), fourth-party logistics (4PL) and fifth-party logistics (5PL) services (value-added logistics services, logistics consulting & management and end-toend supply chain optimization services)
  - Smart and sustainable logistics (green logistics, smart logistics and providers of relevant technological solutions)
- ◆ 每間公司 / 機構就每個獎項類別只能提名一人。
  Each company / organisation is allowed to nominate no more than one individual for each award category.

# 評審準則及過程 Adjudication Criteria and Process

評審委員會由政府及物流業界代表組成,成員包括運輸及物流局代表、香港物流發展局的成員以及其他來自物流業不同領域的業界翹楚。評審委員會會按以下五大準則作評審,並會設定基準分數以決定得獎者名單。

The Judging Panel, composed of representatives from the Government and the logistics industry, with membership including a representative from the Transport and Logistics Bureau, members of the LOGSCOUNCIL and other industry leaders from various sectors of the industry, will conduct adjudication based on the following five major criteria and will set benchmark scores to determine the list of awardees.

#### 兩階段評審制 Two-stage Adjudication Process

<mark>第一階段:</mark>根據提名表格及資料對獲提名者進行評分

1st Stage: Nominees will be scored based on the written submissions and information

<mark>第二階段:</mark>與在第一階段得分最高的獲提名者進行面試以選出得獎者

2nd Stage: Highest-scorers from the 1st stage will be shortlisted for subsequent interview for selection

of winners

秘書處會於第一階段評審結束後,以書面通知入圍之獲提名者有關後續面試的安排。入圍之獲提名者必須出席 後續面試方能取得獲獎資格。

After the completion of the 1st stage of adjudication, the Secretariat will notify shortlisted nominees in writing about the arrangements for the subsequent interviews. Shortlisted nominees must attend the interviews to qualify for the Awards.

# 頒獎典禮 Award Presentation Ceremony

頒獎典禮將於2025年11月18日舉行,有關資料將於稍後提供予獲提名者。秘書處或會向得獎者索取進一步資料 作宣傳之用。

得獎者必須親身出席頒獎典禮以領受獎項。如未能親身出席,得獎者將被視作自動放棄獲獎資格。得獎者不可 授權代領或補領獎項。

The Award Presentation Ceremony will be held on 18 November 2025. Relevant information will be provided to the nominees in due course. The Secretariat may request further information from the winners for publicity purposes.

The winner must attend the Award Presentation Ceremony in person to be eligible to receive the award. The winner(s) shall be disqualified if he / she is absent from the ceremony. Any authorised third-party is not allowed to receive the award. Requests for receiving the award in occasions other than the ceremony will not be entertained.
