## Session 01 | Transport Policy and Its Influence to Our Future City |

Dr. Dorothy Chan, FCILT and Hon. Fellow has extensive experience in urban transport management and regulation. Dr. Chan will share her insights on the latest challenges faced by Hong Kong in maintaining urban mobility and draw on overseas experience to highlight the inadequacies and future options. The pandemic has deepened our concern on public transportation and whether new travel pattern would emerge with increasing acceptance on virtual meetings and working from home.

Traditionally, public transport modes play their roles based whether they are mass carriers or a form of supplementary transport services. The advance of technology will change this perception with passengers' wish determining their optimal choice of routes and services. Is Hong Kong behind or ahead of other world cities in exploring solution and showing a clear journey for the future.

## Speaker Profile

Dr. Dorothy T.F. Chan is the Deputy Director, School of Professional and Continuing Education, The University of Hong Kong (HKU SPACE) and Head of Centre for Logistics & Transport; an Independent Non-Executive Director of MTR Corporation Ltd. and AMS Public Transport Holdings Ltd.

Dr. Chan retired as the Deputy Commissioner for Transport of the HKSAR Government in 2002. She was awarded the Bronze Bauhinia Star for meritorious service in transport. She promotes the development of professionalism in transport through her involvement in The Chartered Institute of Logistics and Transport (CILT). She was the International President of the Institute (2013-2014) overseeing branches in 35 territories with over 30,000 members. Founded in 1919, the Institute is the leading global professional organisation providing education, training and professional networking platform for members. She is the Immediate Past Global Chairperson and Advisor of Women in Logistics and Transport in the Institute. She is an Honorary Fellow and advisor to the Council of Trustees of CILT. In 2021, she received an Enduring Member Award from CILTHK.

Dr. Chan is closely involved in training and professional development in the field of transport and public administration. She has been engaged in the education field and research topics on China and overseas transport projects. She is a Member of International Steering Group on Mega Projects of Bartlett School of Planning of University College London. She is a member of the Board of Governors of the Hong Kong Institute for Public Administration. She is also a council member of MTR Academy (HK) Co. Ltd. and a Director of TWGHs E-Co Village Limited Board.

On public services, Dr. Chan is the Chairperson of Sustainable Agricultural Development Fund Advisory Committee and a member of the Commercial Letting Panel of the Western Cultural District Authority Board. She was a Member of Advisory Council on Environment and the Chairperson of the Environmental Impact Assessment Sub-Committee (2007-2014). Dr. Chan was a Member of Social Welfare Advisory Committee (2009-2014). She was also a Board Member and Finance & Administration Committee Chairperson of Logistics and Supply Chain MultiTech R&D Centre Limited (LSCM) (2011 – 2018).
