# Session 03 | Reinstating Railway Freight Service Between Hong Kong and The Mainland |

On 2 March 2022, the first cross-boundary freight train arrived in Hong Kong. The former Chief Executive, Mrs Carrie Lam and other government officials and guests welcomed the first train transporting anti-pandemic goods from the mainland to Hong Kong destined at the Lo Wu marshalling yard. With this, we can see an opportunity to restate a regular railway freight service by building a freight terminal with facilities like cargo integration, consolidation, and warehouses in the Northern Metropolis development. These facilities will reduce the pressure on land transport logistics and offer the logistics industry great work. It is considered as a rare opportunity that helps the Hong Kong Railway industry to become a "China Railway Express" member. The speaker, Mr. Simon Chan, will share with us his insights and lead us looking into this issue.

Mr. Simon Chan joined the Kowloon-Canton Railway British Section in 1978 as a Senior Railway Officer and was seconded to the British Railway. During the period, Mr. Chan promoted to the Head of Marketing and participated in the railway electrification and double-tracking projects; since KCR became a public corporation (KCRC), Mr. Chan was responsible for the commercial and property development. After leaving KCRC, Mr. Chan joined a publicly-listed company as Chairman, established a subsidiary of China Railway Construction Corporation in Hong Kong as a shareholder and director, and formed a JVC, which won four civil engineering contracts from West Rail.
