It is committed to advancing the strategy of "economic development promoters", to echo the national development strategies, such as the "14th Five-Year Plan", the "Outline Development Plan for the Guangdong-Hong Kong-Macao Greater Bay Area" and the Belt and Road Initiative.

Ms Louise Ho, Commissioner of Customs and Excise, will share with us how Hong Kong Customs applies advanced technology and port infrastructure to help Hong Kong strengthen its intermodal transport, leverage its advantages in handling high-value goods, and consolidate Hong Kong's leading position as a regional logistics hub in the Greater Bay Area and facilitates local logistics industry to promote the development of high-end and high value-added logistics services through various trade facilitation programmes.

**Commissioner of Customs and Excise | Hong Kong SAR Government**

Ms Louise HO Pui-shan joined the Customs and Excise Department in 1991 as a Probationary Inspector. She was promoted to Senior Superintendent in 2013, Assistant Commissioner in 2017 and Deputy Commissioner in 2019. She was appointed as Commissioner of Customs and Excise in October 2021. Ms HO has served in various posts in the Customs and Excise Department, responsible for matters such as intelligence and investigation, human resource management, border control and customs clearance facilitation.

Ms HO has received numerous awards during her career. She was awarded Hong Kong Customs and Excise Long Service Medal in 2009 with the first Clasp in 2016, Hong Kong Customs and Excise Medal for Meritorious Service in 2017 and Hong Kong Customs and Excise Medal for Distinguished Service in 2022.

Ms HO holds a Master's Degree in Public Administration. During her service, she has attended courses at a number of Mainland and overseas institutions, including the National School of Administration and Tsinghua University.
