Special arrangements for the AGM

Prior on-line registration or By Proxy

Members who wish to attend the AGM in person may register their interest by providing their full name, membership number, contact telephone number and email address to CILTHK at info@cilt.org.hk on or before the deadline i.e., Tuesday, 5th September 2023 at 18:00 hours.

For those who wish to cast their votes by proxy, they should complete and submit the Proxy Form as per Appendix III on or before the deadline.

All registrations for attendance in person and submissions of proxy form shall reach CILTHK office on or before the deadline.

Notification

Members who have completed will be notified by email on or before Wednesday, 6th September 2023.

No impairment of right by proxy

Institute Members are reminded that physical attendance to the AGM is not a must for exercising their rights. They can opt for appointing the Chairperson of the AGM to act on behalf of them for casting votes by way of proxy. But they should submit their proxy forms on or before the deadline.

Time control of the AGM

The AGM proceedings will focus on the proposed resolutions which are required casting votes by members. In order to ensure efficiency of the AGM, if questions/enquiries from members that could not be handled at the meeting, they will be responded accordingly after the AGM as and when necessary.

No external food or drink at the meeting venue

No external food or outside drink will be allowed at the AGM venue.

Discipline at the meeting venue

- Hotel staff at the AGM venue will assist in crowd control and queue management at the entrance of the AGM venue to facilitate the venue entry of individuals.
- Due to the limited seating of the venue, attendees will be assigned seats at the AGM venue.
- For those who fail to observe the instructions given by hotel staff or CILTHK office staff at the meeting venue, they will not be allowed to enter the meeting venue or will be expelled from the meeting venue.

Inclement Weather

In case of inclement weather is encountered, the following arrangements for the CILTHK AGM will be executed.

- If Typhoon Signal No. 8 or above, or Black Rainstorm Warning Signal is hoisted or issued but is lowered before 16:00 hours on Thursday, 7th September 2023, the CILTHK AGM 2023 will be held as per scheduled; or
- If Typhoon Signal No. 8 or above, or Black Rainstorm Warning Signal is hoisted or issued at 16:00 hours or the Hong Kong Observatory has issued special announcement to give advance notice that Typhoon Signal No. 8 or above, or Black Rainstorm Warning Signal is expected to be hoisted during the time period from 16:00 hours to 19:00 hours on Thursday 7th September 2023, the CILTHK AGM 2023 will be rearranged at the same venue at 19:00 hours on Thursday, 14th September 2023.

If the AGM is required to be deferred to Thursday 14th September 2023 due to inclement weather, all proposed motions set out in the Notice of the CILTHK AGM 2023 will remain unchanged.

All forms of proxy deposited to the Institute for the purposes of the CILTHK AGM 2023 will remain valid at the AGM on the fallback date of Thursday, 14th September 2023.

If the CILT AGM 2023 will also be cancelled on Thursday, 14th September 2023 due to inclement weather, the Institute will announce a new date on the CILT AGM 2023 in due course.
