#### Special arrangements for the AGM Prior on-line registration or By Proxy

Members who wish to attend the AGM in person may register their interest by providing their full name, membership number, contact telephone number and email address to CILTHK at **info@cilt.org.hk** on or before the deadline i.e., **Thursday**, 28<sup>th</sup> August 2025 at 18:00 hours (HK Time).

For those who wish to cast their votes by proxy, they should complete and submit the Proxy Form as per Appendix III on or before the deadline.

All registrations for attendance in person and submissions of proxy form shall reach CILTHK office on or before the deadline.

#### **Notification**

Members who have completed it will be notified by email on or before Friday, 29th August 2025.

#### No impairment of right by proxy

Institute Members do not need to attend the AGM in person to exercise their rights. They may appoint the Chairperson as their proxy for voting, provided they submit proxy forms by the deadline.

#### Time control of the AGM

The AGM proceedings will address the proposed resolutions that require members to cast votes. To maintain the efficiency of the AGM, any questions or enquiries from members that cannot be addressed during the meeting will be responded to after the AGM as appropriate.

#### No external food or drink at the meeting venue

No external food or outside drink will be allowed at the AGM venue.

### Discipline at the meeting venue

- Restaurant staff at the AGM venue will assist in crowd control and queue management at the entrance of the AGM venue to facilitate the venue entry of individuals.
- Due to the venue's limited seating, attendees will be assigned seats at the AGM venue.
- For those who fail to observe the instructions given by restaurant staff or CILTHK office staff at the meeting venue, they will not be allowed to enter the meeting venue or will be expelled from the meeting venue.

#### **Arrangements under Inclement Weather**

In case of inclement weather, the following arrangements for the CILTHK AGM will be executed.

- If Typhoon Signal No. 8 or above, Black Rainstorm Warning Signal or Extreme Conditions Signal is hoisted or issued but is lowered before 16:00 hours on Monday, 1st September 2025, the CILTHK AGM 2025 will be held as per the schedule; or
- If Typhoon Signal No. 8 or above, Black Rainstorm Warning Signal or Extreme Conditions Signal is hoisted or issued at 16:00 hours or the Hong Kong Observatory has issued special announcement to give advance notice that Typhoon Signal No. 8 or above, Black Rainstorm Warning Signal or Extreme Conditions Signal is expected to be hoisted during the time from 16:00 hours to 19:00 hours on Monday, 1st September 2025, the CILTHK AGM 2025 will be rearranged at the same venue at 19:00 hours on Monday, 8th September 2025.

If the AGM is required to be deferred to Monday, 8<sup>th</sup> September 2025 due to inclement weather, all proposed motions set out in the Notice of the CILTHK AGM 2025 will remain unchanged.

All forms of proxy deposited to the Institute for the purposes of the CILTHK AGM 2025 will remain valid at the AGM on the fallback date of Monday, 8<sup>th</sup> September 2025.

If the CILT AGM 2025 is cancelled due to inclement weather on Monday, 8th September 2025, a new date will be announced by the Institute no later than **30th September 2025**.
