This is our sixth bulletin, created to keep members informed of global best practice responses to the current crisis. This issue is the last of our research topics and looks at business continuity and risk.

Once again we are using our international reach to bring you information on how different regions and countries are responding to the logistics and transport challenges we face. We follow this up with our webinar on the same subject on June 17th, so please join that, or listen to the recording on the website after the event.

Businesses are experiencing the greatest global disruption of our lifetime. Not since the events of the Second World War has there been an international crisis of this magnitude. Continents like Asia and Africa have experienced epidemics before, and countries and regions like Syria, Iraq and Afghanistan have experienced catastrophic conflicts and wars, but the economic and social impacts of the Covid-19 pandemic exceed many times over any such events in the past 75 years. Businesses have had to rapidly review their contingencies and plans. High level risks are open-ended and undefined, but known to be business and life threatening. Nobody can say they had built in preparation for this event, despite pandemics having occurred regularly throughout human history.

In this bulletin we analyse the challenges to business continuity and look at examples of regional problems and responses. Effective management strategies are yet to be fully formulated. This is a topic that is here to stay and will need a constant focus over the coming months. Start by thinking of the possible approaches now and for the future, and share your experiences and solutions with us in the coming months.

He has significant operational and leadership experience across all aspects of supply chain.

The Changing Shape of Learning and Professional Development

The learning landscape has changed dramatically over the past 3 months, but it is still important to keep developing as a professional – in fact it's probably more important than ever that we think about stretching our skills sets and being adaptable.

Learning new skills and developing your team is probably counter-intuitive right now given the immediate work pressures, but it's a key component of preparing for Covid-19 recovery and safeguarding business resilience.

For many businesses 'people skills' now form a critical part of success or failure, and the ability to swiftly change practices, behaviours and approaches will be vital in supporting individual business and the wider economies across the world. Smart use of coaching, mentoring, team-building and wider softer skills sets will be essential – as well as stretching the application of transferable skills.

Our International Training Provider Survey

Next week we'll be releasing our Global Training Insight report which looks at how our training providers have responded to the Covid-19 crisis and the way in which education needs have been redefined and shaped. This will give helpful information to our CILT country organisations, and our training partners, but also some helpful insight to you as members.

Focus on Business Support and Recovery

CILT is already developing proposals in a number of countries for providing business support services through the use of coaching, mentoring and direct advice. This is designed to help businesses, and particularly smaller enterprises, with the Covid-19 recovery phase and covers business resilience, risk management and other processes. Our pilot, funded through USAID and the DAI development agency based in Kazakhstan, will be launched later this month in the Central Asia Region.
