Needless to say, the most immediate priority for us now is the celebration of the 55th Anniversary of CILTHK. We are organising various events and activities for this year-long celebration. The pre-cursor event of the 10th Anniversary Dinner of WiLAT HK took place in Hong Kong Parkview on 23 November 2022. It was attended by more than 100 members and guests. For the first time in CILTHK history, we have organised a series of Executive Luncheons with distinguished guest speakers. So far we have held three luncheons on 21 March, 22 May and 27 June this year inviting Ms Louise Ho Pui Shan, Commissioner of Customs and Excise HKSAR Government, Mr Chris Tang Ping Keung, Secretary of Security HKSAR Government, and Mr Algernon Yau Ying Wah, Secretary of Commerce and Economic Development HKSAR Government respectively. The occasions provided our members the chance to meet and speak to the officials in person and get to learn of some of the interesting stories not usually covered in the media regarding how the various bureaus and departments formulate policies.

Aside from the Executive Luncheons, we have organised various webinars/seminars, for example the "Net Zero Transition in the Transportation and Logistics Industry" Webinar on 25 October 2022, the "Cyber Risk Solution to Marine Industry" Webinar for Hong Kong Maritime Week 2022 on 22 November 2022, "CILTHK 2-day Course 2022" jointly organised with HKARMS, HKIE, IPSHK and IMechE and the "Trade and Facilitation Schemes" by the Hong Kong Customs and Excise Department

of the HKSAR Government on 5 June 2023, just to name a few. Several visits were also arranged since the COVID restrictions were removed e.g. Technical Visit to HKIA on 15 June 2023 and total 20 participants joined the visit.

At the same time, we are continuing to be vocal about our views and positions on all related policies such as the "Import and Export (Amendment) Bill 2023", the proposed amendments to the "Protection of the Harbour Ordinance", "Cycle Track between Tsuen Wan Bayview and So Kwun Wat", "Kau Yi Chau Artificial Islands Scheme", "Road Harbour Crossing Toll Proposal", "Strategic Studies on Railways and Major Roads beyond 2030" and etc. by submitting our formal views to the bureaus and departments concerned as well issuing press releases. In addition, we are also addressing to other research topics, for instance, a press conference was held last year about the "Northern Metropolis and West Tuen Mun Land Use for Logistics" and a WiLAT seminar was held on 20 July 2023 on the topic of "Diversity and Inclusion".

Equally important is our reinforced focus on our Next Generation – the future of CILTHK. Many activities are being planned and organised by our NG Committee and please watch this space! Lastly, please mark down two very important dates on your calendars: the CILTHK AGM on 7 September 2023 and the Gala Dinner – finale event of the 55th Anniversary celebration on 2 November 2023. I would like to end my message with one plea: be proud of being a CILTHK member and please help promote to your friends and colleagues to join our family too!

The Chartered Institute of Logistics and Transport in Hong Kong supports legislative proposals under Import and Export (Amendment) Bill 2023 for transhipment of alternative smoking products

The Chartered Institute of Logistics and Transport in Hong Kong (CILTHK) supports the legislative proposals under the Import and Export (Amendment) Bill 2023 (the Bill) as announced by the Government yesterday (22 March 2023) for transhipment of alternative smoking products (ASPs). It aimed at seeking the resumption of the transhipment of ASPs from the Mainland via Hong Kong International Airport to overseas markets under a new control and regulatory regime.

CILTHK welcomes the Government's attention to the prohibition of intermodal transport of ASPs, which has caused huge losses to Hong Kong's air cargo transhipment industry, as well as Hong Kong's overall economy, especially air cargo exports. After the relaxation of restrictions on transhipment, the industry will fully cooperate with the Government in implementing the new control scheme that will be managed, supervised and enforced by the Customs and Excise Department, so as to strengthen the supervision on intermodal ASP transhipment and prevent alternative cigarettes from entering the market.

The Institute looks forward to the resumption of the intermodal ASP transhipment via Hong Kong as soon as possible, so as to consolidate Hong Kong's position as an international aviation hub as prescribed in the "Outline of the Fourteenth Five-Year Plan for the National Economic and Social Development of the People's Republic of China and the Long-Range Objectives Through the Year 2035".

The Chartered Institute of Logistics and Transport in Hong Kong supports HKSAR Government on new toll plans for three road harbour crossings on 2 August 2023

The Chartered Institute of Logistics and Transport in Hong Kong (CILTHK) would like to express our support to the Government's new toll plans for three road harbour crossings to rationalise cross-harbour traffic and alleviate congestion at such crossings, after its takeover of the Western Harbour Crossing (WHC) franchise on 2 August 2023.

We could see that the flat rates for all tunnels during normal and off-peak hours could lead to drivers' choice on tunnels based on route distance rather than distorted by toll level. A surcharge during peak hours could also reduce the usage of private cars could effectively reduce the traffic congestion for the cross harbour tunnels.

At the same time, the Institute would like to point out that reducing traffic congestion will not only improve public transport services, but also benefit most citizens.

Session 01: The Mission and Role of Hong Kong Customs in Trade Facilitation, 21 March 2023

Ms Louise Ho, the Commissioner of Customs and Excise, shared how Hong Kong Customs applies advanced technology and port infrastructure to help Hong Kong strengthen its intermodal transport, leverage its advantages in handling high-value goods, and consolidate Hong Kong's leading position as a regional logistics hub in the Greater Bay Area and facilitates local logistics industry to promote the development of high-end and high value-added logistics services through various trade facilitation programmes.

Session 03: Trade Facilitation Measures to Strengthen Hong Kong's Status as an International Trade Centre, 27 June 2023

Mr Algernon Yau, the Secretary for Commerce and Economic Development, shared the latest updates of various policies to strengthen Hong Kong's status as a prominent international trade centre and logistics hub, for example the development of various trade facilitation measures in Hong Kong, including the Trade Single Window, infrastructure development such as the redevelopment of the Air Mail Centre as well as liberalisation measures under the Mainland and Hong Kong Closer Economic Partnership Arrangement.

CILTHK Webinar: C&ED Trade Facilitation Schemes Session 01: Exploring global business opportunities with the HKAEO Programme

Ms Szeto Mu Han, Senior Inspector of Office of Trade Relations and Public Communication, introduced the Hong Kong Authorized Economic Operator (HKAEO) Programme. HKAEO formally launched in April 2012, is administered by the Customs and Excise Department (C&ED) under a free, open, and voluntary certification regime. In full compliance with the World Customs Organization's SAFE Framework of Standards to secure and facilitate global trade, the Programme aims to enhance international supply chain security and facilitate movement of legitimate goods, with a view to strengthening the competitiveness and marketability of HKAEOs in overseas market. Local companies involving in the supply chain activities, having complied with the pre-determined general and security criteria, will be accredited as HKAEO, and will enjoy multiple benefits.

Session 02: Enjoy preferential tariff under Customs FTA Scheme

Mr Wan Lai Wai, Inspector of Ports and Maritime Command, introduced the Free Trade Agreement Transhipment Facilitation Scheme (FTA Scheme). FTA Scheme is a voluntary scheme which facilitates goods passing through Hong Kong to enjoy tariff concessions provided under Free Trade Agreements between the Mainland of China and other economies. Customs supervision service and Certificate of Non-manipulation are provided under the Scheme to certify that relevant cargoes have not undergone processing during their stay in Hong Kong.

Session 03: Briefing on Single E-Lock Scheme

Ms Wong Ka Man, Inspector of Land Boundary Command, introduced the Single E-lock Scheme. Single E-lock Scheme was formally launched in March 2016. Under the Scheme, Mainland Customs and Hong Kong Customs monitor and safeguard the security of the transhipment cargo by means of one single electronic lock (e-lock) and global positioning system technology on the principle of 'Across the Boundary with One Single E-lock under Separate Monitoring'. By using a single e-lock, duplicate inspection on the same shipment by both Customs authorities will be reduced at land boundary control points, which helps to streamline the clearance process and expedite the flow of transhipment cargo. It also saves time and cost for the industry and enhances their competitiveness in the market.





CILTHK Luncheon Seminar: Supply Chain Management – Logistics Resilience, 18 November 2022

Disruption to Supply Chains is inherent in the system, but the incidence triggered by the COVID-19 pandemic in 2020 followed by the Russo-Ukrainian War in 2022 has been as devastating as it is unprecedented. And the resulting operational challenges to transport and logistics practitioners have been massive and lasting. The situation is relentlessly exacerbated by the ongoing Climate Change. Mr Eric Wong, FCILT addressed the following questions during the seminar.

- How have the stakeholders been responding to the challenges?

Luncheon Seminar: Adaptation of SMART Maintenance Technologies to Support SMART Railway Operations, 24 March 2023



Congratulations to Professor Anthony Yeh's Innovation! 48th International Exhibition of Inventions


Prof Anthony Yeh, FCILT, Chair Professor of Department of Urban Planning and Design at the University of Hong Kong won a Silver and a Bronze Medal in the 48th International Exhibition of Inventions of Geneva on 28 April 2023.

(1) Smart Address Plates for Pedestrian Indoor Navigation and Location-Based Services and Management (Silver Medal)

Traditionally, pedestrian navigation uses Location Positioning System (LPS) with trilateration to find the user's position, which have very high positioning error for outdoor GPS and indoor positioning. This new solution adopts a cost-effective innovative Location Confirmation System (LCS) to accurately locate and guide the user to the destination by using Smart Address Plates (SAP) that transmit stored geographic coordinates with innovative 3D Smart Address (SA) codes to the users even without WiFi or telephone signals. This SAP system can help to find shops/offices/restaurants/car parking spaces inside a multi-storey building accurately while providing location-based services and management for precise target marketing. It is highly scalable, connecting shops/rooms on a floor to a building, then to a district and to the whole city through a Smart Address Plate Management System (SAP-MS).

The Smart Address Plates and Location Confirmation System were developed by Prof Anthony Yeh, Dr Zhong Teng and Dr

(2) Remote e-Inspection System for the Manufacturing and Delivery of Offsite Modular Construction (Bronze Medal)

This e-Inspection System is a Modular Construction Supply Chain Quality Assurance system that includes i-Core (an IoT device attached to each MC module to monitor the position, humidity, temperature and collision data), e-InStar (an App for uploading the checking result of each production step in a remote factory to the block chain), e-TranStar (an App for monitoring the location and condition of the MC module in the transport process) and a blockchain-based backend. Designed for offsite modular construction use to help solve housing problems, it reduces resources required for supervision and paperwork while ensuring tamper-proof data, helping overcome the current difficulties in monitoring the quality of production and transportation from remote sites. The system has been piloted in an HKU project in Hong Kong with two 17-storey buildings using 952 MiC modules.

The system was developed by Prof Wilson Lu, Director of the iLab of the Faculty of Architecture, together with Prof Anthony Yeh, Chair Professor of the Department of Urban Planning and Design, and Mr KL Tam, Former Director of the Estates Office of the University of Hong Kong.
