


Sustainability and the Green Agenda





Joint Webinar: Road Safety and Road Safety Audit: a HK/UK Perspective, 24 February 2021

With effect from 1 April 2019, the Transport Department has required works departments to carry out Road Safety Audit (RSA) aligned with feasibility design, detailed design and post implementation stages of a project, with a view to enhancing road safety performance. CILTHK joined the Chartered Institution of Highways and Transportation Hong Kong Region (CIHT Hong Kong Region) organised this webinar aiming to share and compare the practice of Road Safety/Road Safety Audits issues and practice in Hong Kong and the United Kingdom. In the webinar, Mr John Dooley, Chartered Professional and Projects Director of Mott MacDonald, brought the participants to

review recently published road collision casualty statistics, emerging trends in transport and their implications for road safety engineers and auditors. A review of current road safety audit practice and design standards were also incorporated.

Webinar Series: 5G Applications for the Logistics and Transport Industry 3 March, 26 March & 8 April 2021

The fifth generation of wireless technology – 5G – represents the changing face of connectivity, 5G is expected to create a new era bringing a new dimension for the logistics and transport industry. With an objective to broaden the knowledge of CILTHK members and audience on the 5G technology, a webinar series with the theme of ‘5G Applications for the Logistics and Transport Industry (網絡研討會系列: 5G在物流及運輸領域的應用)’ connected participants with service providers with a view to devising 5G solutions for the industry. Furthermore, the webinars introduced the Subsidy Scheme for

Encouraging Early Deployment of 5G which was launched by the Office of the Communications Authority (OFCA) under the second round of the Anti-epidemic Fund.

A total of 3 online sessions were arranged in the first quarter of 2021 and over 400 professionals and practitioners in the logistics and transport industry had attended. Speakers from 5G service providers and relevant Government agencies and the logistics and transport industry were invited to share their expertise and insight on the potential application of 5G technology for the logistics and transport industry.





Webinar Series 2020-2021: Smart Cities, Smart Mobility Session III, Digital Platform Onboard for Bus Operations, 11 Mar 2021

New World First Bus and Citybus have been sparing no effort to enhance fleet management, bus safety and passengers' travelling experience with innovative technologies. Mr Newton Ng, CMILT, Head of Commercial of New World First Bus Services Ltd. & Citybus Ltd., explained to the participants how automation in operations has been putting into practice with synchronisation of various devices onboard, including the fully integrated Fleet Management System, Octopus device and Dynamic Information Panel; and how new applications are in place to help restrict driving speed, monitor driving behaviour and even count the number of passengers.

The companies endeavour to facilitate the development of Smart City in Hong Kong, Newton also shared the vision of the two companies of being the first local bus operators agreed to open up real-time bus arrival data with the government for free public use, as well as the introduction of a new electronic payment system in January 2021. The webinar gave rise to a lively and fruitful discussion and the participants found it very informative and interesting.






